

## INFORMATION NOTICE PURSUANT TO ART. 13 OF REGULATION NO. 679/2016 (THE SO-CALLED “GDPR”)

Dear Athlete,

pursuant to article 13 of EU Regulation no. 2016/679, we hereby inform you that Società Sportiva Dilettantistica Tremalzo (hereinafter the Company), with registered office in Ledro (Tn), in Piazza Europa no. 5, as Data Controller, will process - for the purposes and following the procedures described below - the personal data that you will provide to us, including through “DATASPORT AG, Bolacker 1 – CH - 4563 Gerlafingen”, when you submit your request to take part in the Ledro Sky - Senter dele Greste.

In particular, the Company will process the following personal data:

- a) personal and identification data (name and surname and tax code, residence, e-mail, mobile phone number);
- b) health data (considered “special data” pursuant to art. 9 of the GDPR);
- c) video footage and photographs.

### 1. Legal basis and purpose of the processing.

- 1.1. The aforementioned processing is based on your consent to take part in Ledro Sky - Senter dele Greste, a skyrunning race organised by the undersigned amateur sports club.

The purpose of the processing is to organise the event and publish the results of the race, as well as to manage your insurance position.

- 1.2. The processing of data relating to your photographs and video footage is based on your consent and is aimed at publishing this content on the Company's website, in press releases, newspaper articles, books and other types of publications and on the official social media profiles for the race.

### 2. Processing methods

- 2.1. Data is processed, also with the help of electronic means, by means of the operations indicated under art. 4 of the Code and art. 4 point 2) of the GDPR, and more precisely: the processing of personal data may consist of the collection, recording, organisation, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and destruction of data.
- 2.2. Data will be processed using paper and/or computer tools. Data is stored at the company's headquarters, in safe places that are locked with anti-intrusion systems.

### 3. Compulsory data provision

- 3.1. Providing your data for the purposes referred to by points a) and b) is compulsory for you to be allowed to take part in Ledro Sky - Senter dele Greste.

Refusing to provide your data will therefore make it impossible for you to compete.

- 3.2. Providing your data as referred to by point c), for the purposes referred to in point 1.2, is optional.

### 4. Scope of data disclosure

Without prejudice to the provisions of point 2.2. of this information notice, your personal data may be disclosed to the public administrations, DMO, organisations, consultants, accountants and lawyers in order to fulfil legal obligations, as well as to insurance companies to fulfil the relative requirements, to the federation you belong to and other associations and/or sports clubs and/or teams taking part in the competitions.

### 5. Transferring data abroad

Personal data is stored on servers located in Europe.

### 6. Period of data retention

Data will be kept for as long as is necessary to carry out the event and, in any case, for no longer than is allowed for legal purposes.

### 7. Data controller

### 8. Rights of the data subject

At any time, you can be informed of the data concerning you, know how data was acquired, check whether the data is accurate, complete, up to date and well kept, receive the data in a structured, commonly used and machine-readable format, revoke any consent given in relation to the processing of your data at any time and object, in whole or in part, to the use of said data and lodge a complaint with the data protection authority.

You can exercise these rights by making a specific request, to be sent via registered letter - or certified e-mail - to the Data Controller.
